SUMMARY ANNUAL REPORT LABORERS' NATIONAL HEALTH AND WELFARE FUND

This is a summary of the annual report for the Laborers' National Health and Welfare Fund (the Plan), EIN: 52-1601994, Plan No. 501, for the year ended December 31, 2021. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has committed itself to pay certain benefits, Life Insurance, Stop Loss, Short Term Disability, Dental and Accidental Death and Dismemberment claims incurred under the terms of the plan.

Insurance Information

The Plan has insurance contracts with Ullico and Delta Dental Insurance Company to pay certain Life Insurance, Short-term Disability, Dental and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$2,822,341.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$74,544,569 as of December 31, 2021, compared to \$72,653,161 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$1,891,408. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had a total income of \$35,204,825 including employer contributions of \$28,828,749, participant contributions of \$59,100, gains from investments of \$6,146,207, and other income of \$170,769.

Plan expenses were \$33,313,417. These expenses included \$2,434,225 in administrative expenses, \$28,056,851 in benefits paid to participants and beneficiaries and \$2,822,341 in payments to insurance carriers for the provision of benefits.
